3.	<u>Eligibility:</u> Who may enter the Competition?”	<p>To enter the Competition a participant (“Participant”) will be required to, for the duration of the Competition period comply with the following:</p> <ul style="list-style-type: none"> I. the Competition is open to all South African residents who are 18 years and above; and II. who are in possession of a valid identity document or passport; <p>Furthermore, a Participant needs to be in possession of an internet enabled device (“Device”) such as a cellular phone, tablet and/or laptop, such device must have access to the internet.</p> <p>Participants are advised that standard cellular or data rates as per the participants service provider will apply.</p>
4.	Who cannot enter the Competition?
