In these T’s & C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you.”
<b>IMPORTANT INFORMATION</b>		
<b>3.</b>	<b>Eligibility: Who may enter the Competition?”</b>	To enter the Competition, a Participant must be 18 years old, and in possession of a valid South African identity document or passport as well as reside within a 10km radius of Stoneridge Centre.  Furthermore, a Participant needs to be in possession of an internet-enabled device (“ <b>Device</b> ”) such as a cellular phone, tablet, and/or laptop.
<b>4.</b>	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Centre, the marketing service providers, and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners, immediate family members.

7.	<b>Limitation on entries</b>	<p>A Participant can only enter once during the Competition Period and can only win once.</p>
8.	<b>How will the Winner/s be selected?</b>	<p>Through random draw through an online Spin and Wheel</p> <p>The Landlord will select 4 (One) winners (“<b>Winner</b>”) through by automated selection process.</p>
9.	<b>Winner announced on</b>	<p>The Winner will be announced on Friday, 2 August 2024 or at any such date, the Landlord deems fit.</p>

11.	<b>How will the Winner/s be informed?</b>	<p>The Landlord will use all reasonable efforts to contact the Winner using email address and/or telephonically during trading hours between 9am – 5pm (“Trading Hours”).</p> <p>If the Landlord is unable to contact or reach the Winner within 7 (Seven) days of having announced the Winner, the Entry by that person will be disqualified. The Landlord will thereafter be entitled to select another Winner through another electronic selection process. That Winner will also be contacted telephonically, as soon as reasonably practicable.</p>
